CREDIT ACCOUNT AGREEMENT

This agreement made on the date below by the customer below and The Home Lumber & Supply Co (a Kansas Corporation), pursuant to the Consumer Credit Protection Act (Federal Truth in Lending Act) (Public Law 90-321:82 Stat.146) and the Kansas Uniform Credit Code (K.S.A.16(a)-et seq).

The Home Lumber & Supply Co. agrees that if this agreement is approved by the Credit Department, it shall allow the customer to purchase goods or services on credit, and the customer agrees to pay for any goods or services so purchased in accordance with this agreement.

Due Date - All accounts are due in full upon receipt of statement.

Convenience Credit if all purchases on the customer's account are paid in full before the 10th of following month, the account shall not be subject to any finance charges.

Finance Charge – Any account not paid before the 10th of the following month, past due balances are subject to a service charge of 1.5% per month (18% A.P.R.) plus all costs of collection incurred to collect the balance due.

Termination of Credit – The Home Lumber & Supply Co. reserves the right to terminate credit sales at any time. In addition thereto, no additional credit purchases shall be allowed on a account that is 30 days past due.

Notice to Owner - If you pay the contractor for work or equipment, material, or supplies delivered without having received from the contractor a waiver of lien by all subcontractors, or other evidence of payment to all subcontractors, a lien may be filed against your property. You may request a list of subcontractors and material suppliers from your contractor.

Change in Terms – The Home Lumber & Supply Co. reserves the right to change matters of a similar nature within this agreement within the limitations of applicable laws.

The Home Lumber & Supply Co. is hereby expressly authorized to verify any information contained in the credit application. The undersigned customer hereby waives any privacy of credit information and grants permission and authority to the Home Lumber & Supply Co. to share all acquired information with members of the company.
